Continuation of Sales Contract

With NO exceptions, no pet puppy from this litter is to be bred and all pets shall be neutered upon reaching maturity.

Additional Terms:

That the above puppy has been examined by a licensed veterinarian and found to be in good health. That this puppy should be examined by your licensed veterinarian within fourteen (14) days of receipt. If your veterinarian determines the puppy to be ill, or if for any reason this puppy is unacceptable, Buyer may return the puppy for a full refund, provided it is in the same condition as at the time of purchase. If the puppy is returned due to illness, a verified letter from your veterinarian is required.

That said dog will be given adequate and proper shade and housing, and be properly and sufficiently fed. This dog shall not be neglected in any manner and in no manner mistreated. That said dog shall receive adequate and proper veterinary care throughout its lifetime and all inoculations maintained to ensure preventive health care.

That Buyer guarantees Seller right of first refusal if the dog is to be sold or disposed of in any way. If Seller does not wish to acquire the dog, Seller will assist Buyer in placing it. The Buyer may be able to house the dog and provide care until the dog is placed into a new home. The Buyer will be eligible for the proceeds from the resale, less any expenses incurred by the Seller.

That Buyer shall promptly notify Seller of any address change made by Buyer.

That Buyer agrees to prefix "Suncrest Beau Geste" (kennel name) at the beginning of the dog's registered name.

That Buyer agrees to notify Seller of any titles completed as determined by the AKC, GRCA, NAHRA, and others.

That in order for Seller to maintain a quality breeding program, Buyer agrees to notify seller of any major health issues throughout the life of the dog.

That this dog shall not be used for purposes of vivisection nor be sold by or to a wholesale establishment or any chain store, catalog sales house, pet store, or "puppy mill."

Reasonable precautions have been taken to prevent this puppy from acquiring hereditary faults such as hip dysplasia and hereditary cataracts. However, due to the unknown hereditary and environmental causes of such faults, no guarantee will be given against them.

Because the parties recognize that precise damages for breach of this contract might be difficult to ascertain, the parties hereby agree that, in the event of any breach of this contract by the Buyer, the Buyer will be liable for damages in the amount of the purchase price of the dog. In addition, the Buyer will be liable for any and all legal fees resulting from said breach of contract, and all legal matters will be conducted in the state to be specified by the Seller.

The Buyer has read and understands the foregoing and agrees that all parts and portions thereof constitute a binding agreement.
